





Dean, College of Veterinary Science and Animal Husbandry, informed that total faculty strength of the College is 46, out of these, 07 teachers were sanctioned study leave in previous academic session 2018-19 for three years. Now, as on today, effective faculty strength is 39. If above 06 teachers are relieved to pursue Ph.D. programme from Ist Semester of the academic session 2019-20, the faculty strength will come down to 33, which is much lesser than the requirement for the UG, PG and Ph.D. teaching of the college as per VCI requirements. The University has already submitted Self Study Report of different colleges as well of the university in the month of June-2019. The peer review team has already been constituted by ICAR and most likely the visit of team to our university will be held in the last week of September 2019. During the visit, the Accreditation team will verify the faculties required for the Accreditation of college as well of university. Therefore, the Dean has proposed that these 06 teachers may be allowed to start their study leave from the IInd Semester of the academic session 2019-20. The same was approved by the Hon'ble Vice Chancellor and directed to put the proposal in the upcoming Academic Council meeting.

Keeping in view, the interest of university, the members of Academic Council decided to cancel the admission of the above teachers for this academic year (AY 2019-20) so that accreditation and student's study should not suffer. Again admission will be allowed in the next academic year 2020-21 as per university and



VCI rules. The drastic lack of faculty member would be detrimental for accreditation of the university.

271:1575 To take the decision on the strike of the students of College of Fisheries Science.

The Students of the College of Fisheries Science are on strike since 11.09.2019. The Hon'ble Vice Chancellor participated in the meeting, chaired by Hon'ble Agriculture Minister with Minister for State Agriculture, Vice Chancellors of all SAUs of state, Principal Secretary, Agriculture Education and other government officials. The demands of fisheries student's were raised and thoroughly discussed. Principal Secretary asked to submit the details of services being provided by the other states. Hon'ble Vice Chancellor took personal interest and submitted a letter along with documents in favour of student's demands on dated 13.09.2019 by hand to Principal Secretary, Agriculture Education.

On the same day in evening Hon'ble Vice-Chancellor brief the students about the papers submitted in their favour to Principal Secretary and he assured to take up matter with concerned department to meet the demands of students.

In the meantime, Deans, Directors, Hon'ble Vice-Chancellor, Sri Baba Gorakh Nath, MLA/Member of BOM and SDM Milkipur appealed to students to call off the strike because the university has already taken steps to fulfill their demands. Since the demands are not related to university hence, the university has assured to pursue with government to take decision regarding their demand.


The agenda was discussed in the Academic Council and following decisions were taken:
