In this review meeting, 17 KVKs under area jurisdiction of NDUAT participated and made presentation on annual progress report and annual action plan of KVK. In introductory emarks, Dr. S.P. Singh, Director Extension expressed that KVKs should focus on technology assessment and act as knowledge and resource centre in the district. He said that the Programme Coordinator (PC) should develop a brief presentation on major problems, priorities and existing scenario related to market weather; input support; area, production & productivity related data on major crops; significant achievements of KVK highlighting important successful cases of the district and use this at different forums to sensitize different stakeholders. The PC is expected to guide and advise the extension machinery of the district. Use of agro-advisory service through v-KVK should be emphasized to enhance the reach of KVKs to farmers. Infrastructure, resources, soil testing lab, farmer's hostel, residential quarters, etc. of KVKs may be utilized to its full potential. Representation of NGOs, gram panchayat, anganwadi kendras, input dealers, etc. may be considered for training under extension functionaries. KVK has to establish its outreach and recognition in the district by technology dissemination and awareness creation programmes. Revolving fund may be utilized for instructional farm development. In eastern Uttar Pradesh, resource conservation technologies like zero tillage, raised bed, leaf colour chart, land laser leveller, frum seeder, system of rice intensification, etc. need to be further emphasized by the KVKs. He further stressed that in Eastern Uttar Pra farming system models should be developed, interventions on making the rice-wheat system a more profitable system may be pursued. Focus on processing and value addition like banana fibre extraction may be given by developing entrepreneurs. The KVK should have a good technology cafeteria for educating the farmers. Special days like Agriculture Education Day, Farm Innovators Day, Foundation Day and Agri-Industry Day may be celebrated each year by each KVK.

Dr. Bhagwan Singh, Director Research of NDUAT, the Chairman of the Inaugural Session advocated that KVK should work as a team for addressing problematic areas. Development of innovative extension methodologies/approaches is the major role of KVK. Mobile technology has made its reach in the rural areas, it may be utilized by the KVKs for faster technology dissemination. KVK should have material, appropriate technology, technology, test methodology and information support for benefiting the farmers of the district. Effect of training on farmers & entrepreneurs may be studied. The delivery and work of KVKs need to be enhanced commensurate to fund allocation & expectation. Monitoring, guidance and technological backstopping at SAU level are needed for effective functioning of KVKs. A team of experts of Directorate of Extension reviewed the progress and action plan of 17 KVKs. The important observations recorded during presentation are as under, which may be included in the Progress Report 2016-17 and Action Plan 2018-19 by all the KVKs as reference of the technology for the district:

- Focus on Rabi maize, fisheries, resource conservation technologies, perennial grasses, fodder crops, etc. may be given.
- Each SMS should conduct at least one On Farm Trial in each season. Twelve OFTs may be planned by each KVK. The Programme Coordinator should also conduct front line demonstrations and On Farm Trials.
- For latest cultivar and technologies of pulses, the KVKs should contact the IIPR, Kanpur for getting seed & technology and for other commodities, the concerned Agricultural Universities/ICAR institutes may be approached.
- SMS (Home Science) should give more focus on drudgery reduction, nutritional garden and economic development in the villages. A model nutrition garden should be developed at the KVK also.
- Enterprises for land less farmers should be planned including poultry, goatery, bee keeping, mushroom cultivation, etc. Villages having more than 30% tribals may be adopted by the KVKs specially Sonbhadra, Balrampur, Maharajganj, Gonda,
- Problem cause analysis should be done by the KVKs to design the realistic on farm trials. Common On Farm Trials on Swarna Sub-1, Chiran Sub 1, Sambha Sub-1 in flash flood areas may be developed by the KVKs of eastern Uttar Pradesh.
- Usar Dhan-3, CSR-36, CSR-43 cultivars of paddy may be promoted in usar affected areas by all the affected KVKs.
- Kashi Uday cultivar of vegetable pea in place of Arkel may be promoted.
- Activities on minor millets may be planned by KVK Sonbhadra and Mirzapur and related crop cafeteria may be developed at the KVK.

- It has been observed that there is a need of clearity regarding the NARI project. This project is designed for the nutritional empowerment of farm families. It is therefore required to consider the holistic approach. In this context the association of the Agronomy and horticulture discipline is as important as Home Science Scientist.Action Plan for NARI should be reframed and submitted to ATARI, Kanpur directly. It was also decided that the farm families in DFI villages may be selected for the implementation of the project. Nutritionally rich crop/varieties must be given priority for cultivation in this project along with coarse and minor Millets. Proven technologies should be included in the programmes.
- Target of soil sample to be analysed and Soil Health Card to be made as per the resources. However it is very much needed to analyse the impact of Soil Health Card on the total consumption of fertilizer and the ultimate effect on the economics.
- · During the presentation it has been observed that in majority, IFS has not been initiated yet; therefore the specific district wise programme for IFS should be framed. It is also essential to mention that the budget allotted for this programme could not be utilized earlier due to one or other regions and therefore the efforts of the Head Quarters level is required to reallocate the budget with ATARI, Kanpur.
