Students Grievance Redressal

Any complainant (student) can lodge the complaint in person/by Post/Phone/Email to the nodal officer of grievance cell of the concerned college as there are separate nodal officer for Grievance redressal for each constituent College/Unit of the University. Immediately after receiving the complaint from any student, it is acknowledged within 24 hours. If the complaint is received by DSW or any other authority of the university, it is communicated to the concerned nodal officer for redressal. Then, the matter is redressed by the nodal officer through enquiry by the students Grievance Committee. The nodal officer communicate the resolution to the complainant for redressal within 10 days. If complainant gets satisfied, the complaint is resolved. If not, it passes on to the next stage to the Directorate of Administration as an appeal.
